I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND THE CONTRACT BETWEEN MYSELF AND THE CITY OF PALM DESERT, DESERT RECREATION DISTRICT AND RONNIE’S HOUSE FOR HOPE, THE STATE, THE COUNTY AND ALL THE LESSOR, AND SIGN IT OF MY OWN FREE WILL.
